Description of Categories:

The Oregon Hearth, Patio & Barbecue Association represents and promotes the interests of the hearth, patio and barbecue products industries. Hearth products include fireplaces, stoves, decorative and functional accessories, fuels and all other hearth related products.

Hearth, Patio & Barbecue Association (HPBA) membership is available to manufacturers and distributors of any product and services sold through the hearth, HVAC, casual furniture, or barbecue distribution network and to those that manufacture or distribute any products promoted at HPBA's annual trade show. Companies must join OHPBA/HPBA in the membership category that represents the largest proportion of their business.

Note: For U.S. Federal income tax purposes membership dues may be deductible as business expenses, not as charitable contributions. The Omnibus Budget Reconciliation Act of 1993 requires OHPBA to inform each member that an estimated 10% of dues will be allocable for lobbying expenditures as defined by the Act and therefore are not deductible as business expenses.

Any company that manufactures, brands or imports appliances, fuel or any other hearth-related products sold or distributed through the hearth, patio/casual furniture, or barbecue distribution network, or those that manufacture any product promoted at HPBA's annual trade show.
